## **Positive EV Update from Consumer Reports**

We don't typically include news items that are beyond our region's scope. However this item may not be covered elsewhere and is important enough for us to pass it along.

Recently, *Consumer Reports* has been fairly critical of EVs in their ratings. They have just updated their EV ownership cost analysis from a few years ago and released a fact sheet on the findings.

In CR's comments on EPA's light duty multi-pollutant rule, we have updated our EV ownership cost analysis from a few years ago and just released a fact sheet on the findings. This time we looked at 6 mainstream EVs that qualify for at least part of the IRA tax credits.

Key messages:

- All 6 EVs offered savings in the first year of ownership when financed.
- Lifetime savings averaged about \$10,000 for the 6 vehicles with a range of \$6-12k.
- Telsa's most affordable models are cheaper to own than the comparable Toyota by a significant margin.
- All of these savings are despite 3 of the 6 EVs selling at significant markups and many of the comparable ICE vehicles selling at significant discounts to MSRP (analysis is based on market price), meaning savings have room to grow as EV prices get back to MSRP or less.

### EVs Made a Difference on Independence Day

Over 85,000 electric cars have been sold in the Sacramento region. Each year, taken together, driving these cars:

- Saves about 40 million gallons of gas
- Eliminates over 7,500 gas tanker truck loads of fuel
- Eliminates over 2,000 train tanker cars of oil
- Saves over 500 million gallons of water (from oil refining)
- Saves over \$200 million in fuel purchases

EVs are widely available, with more than 110 models on the market. Prices for new EVs start in the low \$20,000s, and there is a strong used EV market.

### Update, El Dorado EV Purchase Incentive

El Dorado County Air Quality Management District is still implementing their \$599 Drive Clean EV Incentive program.

#### You must apply before purchase. Pre-approval is still required. Apply **HERE** before shopping for an EV

It's an incentive for those considering purchasing/leasing an EV. Over 736 EVs have been incentivized to date.

Additionally, the El Dorado County Air Quality Management District has installed over 100 level 2 EVSE at public facilities and private businesses. Some of the newest ones are at:

- EDC Senior Center
- Georgetown Library
- El Dorado Community Health Center
- Rucksack and Sierra Vista Wineries

Over the next year or so they will be swapping out the 55 free-for-use Clipper Creek EVSEs at County owned facilities (libraries, parks ...) with new EVSEs that will collect a fee for use. There



has been too much abuse of the free chargers, particularly in El Dorado Hills. [Abuse has not been specified]

The district is also developing a new home EVSE incentive program that will be called CHARGE. El Dorado County will provide up to \$300 to residents who own or lease an EV to purchase and install a level 2 EVSE at their homes.

#### **Sacramento County Backpedals on Climate Emergency**

In 2020, the Sacramento County Supervisors adopted a Climate Emergency Declaration with a target of achieving carbon neutrality by 2030. On Tuesday, July 11, they will consider delaying that date by 15 years to 2045. Peter Mackin as part of 350 submitted comments <u>here</u>.
