
Vehicle Tax Credits and Rebates

Up to \$25,500 in tax credits and rebates.

Federal Tax Credit

You may qualify for a credit up to \$7,500 under Internal Revenue Code Section 30D if you buy



Typical amount: Up to \$7,500

California Clean Vehicle Rebate Project

The California Clean Vehicle Rebate Project offers rebates for the purchase or lease of qualified vehicles. Low income applicants gain



higher incentives. Typical amount: \$1,000 - \$7,000

California Vehicle Retirement Consumer Assistance Program

The Consumer Assistance Program provides \$1,000 to \$1,500 to support the retirement of old, polluting vehicles. Typical amount: **\$1,000 - \$1,500**

<u>California Clean Vehicle Assistance Program Beneficial State Foundation</u>

Beneficial State Bank has committed to providing loans at an 8% interest rate or lower to participants of the Clean Vehicle Assistance Program.

Sacramento Clean Cars 4 All--Turn in Clunker!

Clean Cars 4 All is a Sac Metro AQMD program to help income-qualified residents purchase a qualified EV. You must turn in a 2005 model year or older car to receive up to \$9,500 for purchase or lease of a new, eligible PHEV, BEV, FCEV, OR up to \$9,500 for purchase of a



used PHEV, EV or FCEV less than 8 years old with <75K miles and clean title. You may be eligible for an extra \$2,000 in charging support. Restrictions may apply when using other CA incentives. Join the waitlist of Clean Cars 4 All on the website. Typical amount: **Up to \$9,500**

Charging Station Incentives

<u>Federal Alternative Fuel Infrastructure Tax</u> <u>Credit</u>

Customers who purchase qualified residential fueling equipment after January 1, 2023, may



receive tax credits up to \$1,000. Typical amount: Up to \$1,000

California PACE Loss Reserve Program

The PACE Loss Reserve Program administered by the California Alternative Energy and Advanced Transportation Financing Authority (CAEATFA) works with partners and lenders to support financing for energy or water efficiency and clean energy home improvements. Property owners in PACE-designated areas can use this financing for home improvements without a down payment and repayment in their property tax bills. See if PACE serves your county!



SMUD Charge@Home Incentive

The new SMUD Charge@Home incentive program will lower the cost of a qualified Level 2 charger for home and/or home electrical costs needed to install a Level 2 charger. Typical amount: **Up to \$1,000**



Electricity Discounts

SMUD Discounted Electricity Rate

SMUD offers plug-in electric vehicle owners an additional 1.5¢/kWh credit for charging an EV midnight to 6 am every day, all year long.



Driving Perks

California HOV Lane Exemption

EVs may use HOV lanes regardless of number of occupants in the vehicle.



Sacramento EV Monthly Parking Permit

Electric vehicles that are owned or leased by individuals or enterprises are eligible for special monthly parking rates in designated parking facilities. Vehicles must be 100% electric. Hybrids do not qualify for the program.
